

◆ Procedures to visit in JFY 2026 (April 2026-) ◆

Register your activity at J-PARC to visit on/after April 2026.

Procedures for JFY 2026 begin from **Monday 16th February 2026**.

1. Update your User Support System

Registered activity is valid for a single FY. **Log in and activate/update your account for use in new FY**

2. Radiation Registration (*)

- Users who have obtained a J-PARC dosimeter in **JFY 2025** are eligible for update to next fiscal year.
- Please complete both of **renewal procedure 1 & 2** to **use dosimeter from March to April continuously**.
 1. Submit '**Application form to visit J-PARC**' for visit in April **by 13th March**.
 2. Submit '**Renew: Radiation Worker Registration Form**' **before visit**.
- Other than above, e.g. visiting is not yet decided, submit the filled form to the Users Office no later than 2 weeks prior starting experiment at J-PARC.

Periodic replacement of J-PARC Dosimeter

Only for person who have applied for renewal procedure (*)

Please visit UO between **Monday, 30th March and Tuesday, 31st March**
to change your dosimeter for Regular dosimetry.

If you did not apply for renewal, return your dosimeter **by 31st March**.

If the experiment is going to continue in the morning, please make sure to **return until 10:00am on 1st April!**

3. Application form to visit J-PARC, Visit proposal [start on/after 1st April 2026]

- Long-term stayers are required to submit via system **by 13th March**. Generally, by 2 weeks before visit.

4. Safety Training (General, Facility and Radiation Safety) for JFY2026

- Long-term stayers are required to complete **by 8th April**.
- Make sure to watch online videos **on/after 1st April**. Invalid record in March.

5. J-PARC User ID card

- Long-term stayers are required to change your ID card ASAP **by 8th April**. Renew the ID card holder.

6. J-PARC Card (key card for experiment facilities and Research building)

- J-PARC card keys issued in JFY 2025 invalid on 31 March 2026.
- Submit 'Application form for J-PARC Card' again to continue using **from March to April**, except for MLF users.
